- Exhibitors and vendors will get 2 vendors badge, any extra badge is \$15 each.
- Food vendors are required to use vinyl or rubber gloves when handling food.
- Food vendors can sell soda, water, or any prepared ethnic drinks and juices. If they pay extra \$50.00.
- Tobacco, illegal drugs, obscene materials and violence are strictly prohibited.
- Electrical outlets are not provided.
- Use of electricity shall be charged depending on the voltage used.
- Handy fuels or warmers are allowed if placed under a chafing dish, no propane gas or open fire are allowed inside the venue.
- Fully cooked food is expected to be served.
- Cleanliness should be maintained, garbage should be properly disposed.
- Food vendors should inform customers if monosodium glutamate is used or any other ingredients that are in question.
